Kawartha ATV Association Advancing care close to home

Members of the **Kawartha ATV Association** (KATVA) find adventure on the trails. They find care at Ross Memorial Hospital. Thanks to KATVA's generous support for the Ross through their annual fundraising Poker Run, patients at the Ross receive the best care possible with access to the latest medical equipment, life-saving technology, and services and spaces that grow with our community.

KATVA's Poker Run on June 1 attracted more than 215 participants with 47 volunteers supporting the ride through the Pinery and Five Points forests, the silent auction, draws and dinner. Their event was more than a big success. It resulted in an impactful donation to the RMH Foundation.

On July 26, KATVA representatives visited the Ross to present their latest gift — a cheque for \$15,000 — to help fund the future expansion of the Emergency Department to include a **Mental Health Emergency Services Unit (MHESU)**.

The MHESU will provide a safe space to prevent self harm, private rooms for crisis care, as well as a private waiting room. Modernized mental health treatment areas will optimize the safety and security of staff and patients and support the projected 44% increase of patients requiring crisis intervention in the Emergency Department. This project is now proceeding through the Ministry of Health capital planning process.

This latest contribution from KATVA brings the group's cumulative giving total to \$65,429. KATVA's donations have supported care for patients in the Mental Health department, Diagnostic Imaging and the Operating Suites, and have helped fund equipment including new Xray technology and IV pumps.

"Our team works hard to deliver the services and care our community relies on. And we know our community works hard to support our team," said Kelly Isfan, RMH President and CEO.

Dragon Flies bring change to breast cancer care in Kawartha Lakes

Around the globe, dragon flies represent good luck, symbolizing change and better times ahead. True to their namesake, the Dragon Flies Breast Cancer Survivor Group is changing the nature of breast cancer care in Kawartha Lakes, and sharing hope through their sisterhood. Since 2002, the Dragon Flies giving has helped the hospital to acquire the best diagnostic technology including 3D Mammography and MRI, and to become an Accredited Breast Assessment Centre with a High Risk Breast Screening program, affiliated with Cancer Care Ontario.

The Dragon Flies host their flagship awareness event, called Diva Night, each year during Breast Cancer Awareness Month. It was during this special event at the Victoria Park Armoury in Lindsay on October 24 that the Dragon Flies announced gifts that would touch even more lives in the Kawartha Lakes. Founding members Nancy Hanna and Jo-Ann Forson presented a cheque for \$10,000 to Erin Coons, RMH Foundation CEO.

"Technology is transforming the world around us, improving our connections and enhancing our access to services we never thought possible a generation ago," said Erin Coons. "The Dragon Flies have played a big role in the transformation underway at the Ross. We're grateful to have such committed community partners helping to grow services and spaces at our local hospital as our patient population expands. Our thanks to the Dragon Flies and to everyone who participates in their fundraising events that impact care throughout the Kawarthas."

With this donation, the Dragon Flies' total giving to Ross Memorial Hospital Foundation reaches \$430,300!

Year End Charitable Giving Reminders

As we approach year-end and you think about any final charitable donations you want to make for this tax year, it's important to have a plan in place for making a timely donation. Be sure that you make those donations early enough so that any delays in processing do not impact your ability to deduct it in 2024.

Cheque and Credit Card Donations

If you plan to send your donation in the mail, to count for 2024, it must be postmarked by Canada Post by December 31. Credit Card gifts to RMH Foundation may be made online up to December 31 at foundation.rmh.org/ways-to-give.

Gifts of Securities

With extremely high trading volumes in December, holiday TSX closures and delayed settlement schedules, it's important to make gifts of securities well before the end of the year, ideally by the first week in December. Gifts of mutual funds and stock can only be receipted when the proceeds settle in the charity's account, not when the transfer is made. Additionally, RMH Foundation is not able to affect nor expedite the time it takes to process a transfer between the delivering and receiving institutions.

To avoid unnecessary delays in transfers, please ensure that you complete our Gift of Securities transfer form, including all requested details and that it is sent to all parties indicated on the form (<u>foundation.rmh.org/</u><u>document/gifts-of-securities-donation-form</u>).

Some Gifts Give Back

By donating publicly-traded securities, you eliminate the capital gains tax that you'd have to pay if you sold the securities and then donated the proceeds. You'll also receive a charitable tax receipt for your gift.

Securities can include stocks, mutual funds, segregated funds, bonds, flow-through shares, and employee stock options. You can give now, or as part of your estate and Will planning.

Giving is simple.

Consult your financial advisor to decide which investments make the most financial and philanthropic impact.

Then ask your broker to transfer your securities to the RMH Foundation by completing the appropriate transfer form. And finally, get in touch and let us know you have made your gift so that we can show our appreciation!

How do I know when I qualify for a plaque on the Donor Wall?

The RMH Foundation keeps records of every donation. Once a donor's total giving reaches \$5,000 we will let you know with a letter. You may choose if you would like to be recognized with a plaque, and if so, how you would like it to read. There is no time limit to make this decision and we will assist you to ensure the wording of your plaque is meaningful to you.

When your plaque is installed on the wall, we will send pictures to you with its exact location.

Each time your cumulative giving reaches the next level of recognition, we will let you know that your plaque has moved to a new giving level. Once again, we will send you pictures so you may find it easily.

Celebrating the Faces of Philanthropy A conversation with Jeff Todd, RMHF Treasurer

What inspired you to volunteer on the Foundation Board of Directors?

I have gratitude debt to the Ross for patching me up as a kid from repairing broken bones, stitches and bouncing me back as quickly as I faltered to my next injury.

What do you hope to accomplish during your time on the Board?

Awareness and engagement across all generations. Enhancing awareness that public funding continues to come up short but that gaps can be minimized with the power of an engaged community from young to old.

Are there things you've learned about the work of the Foundation of which you were unaware before joining the Board?

Philanthropy comes in all shapes and sizes – and it all matters. I love hearing stories of kid lemonade stand donations to a 'thank you' Ross experience donation to local leaders and corporate donors providing a courageous gift. It all matters and giving back is a social muscle that makes our community great.

Has the Ross played a part in your life or the life of a loved one? What is your Ross story?

I vividly recall a number of Friday evenings post our Lindsay Muskie Jr. A games when either myself or a teammate would be injured requiring stitches, a cast or something in between. Our entire team of 20 sweaty teenagers would waltz down to visit our ailing teammate to send them some love. I'm not sure the busy ER would appreciate that today, but the nurses and doctors were very accommodating after a quick visit before kindly and with a smile asking us to leave.

What does the phrase 'WE ARE THE ROSS' mean to you?

I feel very privileged to have the healthcare access that we do in Canada - for my family, parents, kids and loved ones. But I think we need to strive for more than 'access'. I see the 'We are the Ross' as a challenge to the entire Kawartha Lakes community to come together and enhance our experience and services at the Ross. Engage more and demand more. To me, 'We are the Ross' is a sense of community ownership, one in which elevates both our Ross services, experiences and expectations.

The Board is responsible for the overall governance of the Foundation. Its members set the Foundation's strategic priorities and ensure they're met; they monitor the success of fundraising and stewardship efforts, and ensure financial resources are managed appropriately. In addition to monthly board meetings, members serve on various committees of the Board. They are valued members of the RMH Foundation family. All of them made a difference.

The combined support of the participants of the Thankful Hearts Walk on October 3 raised \$4,610 to fund equipment and technology needs in the Cardiac and Pulmonary Rehabilitation program at Ross Memorial Hospital.

Participants chose to walk a 2 km route around the block, or stick to a shorter path through the hospital gardens.

"The Thankful Hearts Walk is bigger than a one-day event," said Erin Coons, RMH Foundation CEO.
